- Taxes 2025 are complete; National AA dues (\$200) have been paid
- National Members, pay your dues (\$175 ea.)
- Physical mail brochure/flier to alumni brothers to encourage brothers to pay dues and show transparency of funds (cost - printing & stamps) - still working toward our goal of 25 members! Only 1 member has paid in 2026: \$35/year or \$ 150 for 5 years. **Pay your dues.** - PayPal needs to be updated.
- Managed Fund money still needs to be allocated to be accessible for Table Talks. Table Talks catering cost is \$2,102.00 due February 6, 2026. The budget does not have a current balance to cover the catering cost, if we were to move the table talks profit to our managed fund. Funds will be allocated after Table Talks 2026. There are currently 10 confirmed firms attending this year (\$400 per firm; estimated profit \$1,898). Table Talks 2025 cost was \$2,234.69 (14 x \$500 per firm; estimated profit \$5,000).
- Brother Jagroop inquired whether our association could set up a debit or credit card for alumni association expenses to lessen the burden on Brothers needing to front costs.
- Brother Brown will complete paperwork for tax-exempt approval (NYS only)
- Convention delegate stipend is \$150 (there will need to be a discussion to increase the stipend if able)

  - Scholarship meeting needs to be established - Brother Van Deusen, Brother Janzen, Brother Imhoff
