- **President**
 - The 77th National Convention is to be held March 27-30, 2025, in Pittsburgh, PA. The last day to register is Monday, February 24, 2025.
 - There are only 5 seats left.

- AA to select a delegate - Brother Garrett Brown, Brother Margaret Scaglione, Brother Chris D'Ambrosia, and Brother Will Van Deusen have seats at convention already.
 - National Tasks are due 3/10. Our association is currently in Good Standing.

- **Vice President**
 - Collegiate Chapter Updates
 - They seem to be running smoothly
 - 16 collegiate members currently
 - Pin-in will take place this weekend; Spaghetti dinner was last night, and now they are doing interviews with potential members
 - Suggestion to increase alumni presence and participation - Brother Janzen will brainstorm with the collegiate chapter
 - We will continue to assist with Ritual Lunch - Spring 2024 and Ritual Lunch - Fall 2024
- **Treasurer**
 - Budget Report

 - Current balance is 7,048.17
 - We had the Financial Taskforce committee tell us that the managed fund is owed 3,600.02. This hasn't been moved because Brother Garrett Brown is unable to write a check

- Scholarship funds will now be taken from the managed funds, as opposed to our annual budget.
- White rose and Ritual lunches will change the current balance
- What's the amount that will be left after we finish all our payments
 - The number should go down to about 1,500, which is our typical budget, and then we will have to pay the bank fees
- Yeah, we are still working on the nonprofit status, so we no longer have to pay that fee
- Treasure will look into the status of taxes
- Ritual Lunch Discussion:
 - A typical lunch might include Wegmans subs and chips
 - The budget is currently \$100; suggestion to increase the budget to \$150 to account for the price of eggs, er, inflation.
- Longevity of Dues-Paying Members:
 - **Pay your dues. You can now pay them easily through GreekTrack**
 - Goal to get 25 paying members
 - Motion to approve the budget and to raise dues to \$35 a year and \$150 every 5 years

 - They have about 70 members
 - Insurance Risk Management Update
 - went through with the insurance provider to see what we can change to reduce the cost of the insurance
 - It doesn't really affect us because we don't have a house
 - Otherwise, the chapter can not be part of a combat sport on behalf of the chapter
- Table Talks was held on Wednesday, 2/19/25. There were 14 paying tables. The talk was about a good work culture. It was one of our least expensive table talks
 - More involvement of an Eboard position with table talks planning
 - estimated 6 to 8 hours a year commitment
 - Treasurer, Secretary, and/or Vice President were suggested as involved members of the Table Talks Planning Committee
 - Brother Nahshon Jagroop and Brother Kelsey Imhoff to assist in planning this year, as executive board members.
 - Planning between the 11th and the 25th of next year for table talks (Will probably go with the 11th since the 25th is too close to midterms)
