- Proposed Budget for 2023 FY (July 2023- June 2024) 0

- that's a deficit of 300 dollars
  - yes but we underestimated the amount of dues we will probably receive
  - it is hard to project what dues we will receive as we have received 750 but this year we received 490 which we are thinking that's because we are coming out of a pandemic and involvement is low because we could not do events
  - if we are projecting a lose already shouldn't we come up with a plan so we don't spend all our savings
  - We are looking into doing more Fundraising to help out and donations are always welcome
